1. Call Meeting to Order-Principal Johansen (until we elect a new Chair)  
Meeting was called to order at 5:00pm by Julie Johansen who is acting Chair.

2. Introductions/Welcome  
Julie called the meeting to order at 5:00 PM (Julie called to order until Chair is elected).
3. Public Comment  
Public comment was opened. There was no public. It was closed at 6:02PM.
4. Approve minutes from the November 30, 2021 SSC Meeting  
Maggie motioned to approve the notes and Mariah seconded the motion to approve the notes. Notes approved by all.
5. Discussion Item-Reports
  - a. S. Rook-Student Representative  
Savannah reported that CMS had a Food Drive from December 6-10 and that 700 lbs of food and \$800 was collected for the food bank. 8th graders brought the most and will get a rootbeer float party tomorrow during advisory. Last day before winter break we had fun games and activities. On Feb. 14th we will have a Valentine's Day celebration with Bingo in the afternoon. Student Council is going to sell Val-e-grams. CMS Leadership Elective is planning to do service learning projects (including cleaning up the campus) next quarter.
  - b. K. Anderson-Certified Representative  
Mrs. Anderson (with the help of Mrs. Freske and Mrs. Hoover) reported that 6th Grade is doing a cross-curricular project using SOAR strategies in ELA and Social Studies researching Native American tribes. 7th Grade is starting the novel Freak the Mighty. 8th Grade is starting a unit on Constitution/Government. We are also

starting CIS and YouScience campus wide. Our school is also part of the Capitol Hill Stock Market Challenge.

c. **B. Wittenborn-Classified Representative**

No report because she is absent.

d. **J. Johansen-Principal's Report**

Mrs. Johansen announced that Mrs. Holst was named Creswell VFW teacher of the year and also the VFW District 13 Teacher of the Year. Her application has now gone on to the state level for judging. Mrs Johansen went over our current attendance numbers. As of today, 25% (69 students ) are considered Chronically Absent and 75% (204) are considered Regular Attenders. Students who have 90% or more attendance so far this year (missing less than 8.5 days) are on track to earn a sundae party at the end of the year. She explained that letters will be going out to families who have students with less than 90%. Mrs. Johansen then went over the I-Ready data that is available. Not all students have finished, so she focused on the ELA results (which most have finished). Students have made major progress so far this year (see document that was presented).

6. **Action Item-Amend/Make Changes to SSC Representatives and Elected Positions**

a. **Elect Kara Freske as Chairperson for 2021-22 school year**

Julie clarified that because students only take the state test one time a year the I-Ready information will be utilized during the year to monitor student growth and set goals. Julie reviewed the attendance information and goal as well. There was a formatting issue in the DRAFT, so Julie will fix this.

Kara made the motion to approve the 2021-22 Continuous Improvement Plan and Cassandra seconded. All in favor.
