The **Public Hearing on the Budget** is to hear comments from the public on the budget as the Budget Committee approved it. Following the public hearing, the Board determines whether the amount to be voted on shall be changed from that in the approved budget as a result of testimony presented at the budget hearing. The amount of tax levy in the published budget may not be increased without a republication of another hearing.

The **Regular Board Meeting** includes an agenda item for the Board to enact resolutions adopting the budget, make appropriations, and declare the tax levy. At the time the budget is adopted, expenditures in each fund of the budget may be increased up to ten percent above that in the published budget provided that the tax levy of the published budget is not increased. To exceed either of these restrictions would require republication of the budget and another public hearing.
